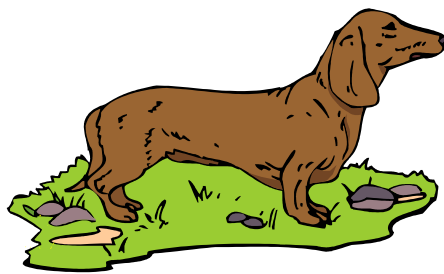

Dog of the Month
Margale's Sawyer MX, AXJ, JE, CE



Editor's Note: "Sawyer" is the first dog we have featured here that does not have a stellar conformation career, but there is good reason!

"Sawyer is a totally cool dog. He was born and lived his first 5 years in Belmont Shore, a little beach community in Long Beach. He came to take care of me when Alex, my red smooth, was dying. Alex and I decided Sawyer was a good name for him since now I knew a lot about being a dachsie mom and could give him great adventures. For lack of anything better to do, we went to puppy kindergarten when he was about 4 months old and, while we were doing all that "SIT, STAY, COME, HEEL, WALK AROUND IN A CIRCLE" stuff in the parking lot of a park, we could see dogs and their humans laughing and jumping and going through tunnels and up ramps. It was clear to both of us that we were in the wrong class! So our agility career was born courtesy of the Long Beach Parks Department

when he was 11 months old. He flew through Novice, took about 6 months in Open, and soon had his excellent titles: MX is a master excellent agility, meaning he got 3 qualifying runs in Ex A, then 10 qualifying runs in EX B. The AXJ title means he has 3 qualifying runs in Ex A Jumpers With Weaves, but not 10 in Ex B.

We started with Earthdog at 6 months, since he wasn't old enough for anything else, and he thought it was a fun game. Not fun enough to get his Senior Earthdog title, however...

The summer of 2004 we moved to Gold Canyon, and had to find new ways to amuse ourselves since it was too hot for agility classes in the summer. We settled in to become desert dachshunds, and Sawyer decided it was time to become a dad. In September he and Becky became the proud parents of The Twain Gang – 2 b/t girls, 2 red girls, and a black and tan boy (named Huck of course). When fall came we started in obedience classes since Rally, which up 'til then was only for fun, was to become a titled event starting Jan 2005! We couldn't find rally classes, so opted for advanced obedience to learn all the moves... We got Sawyer's novice rally title April 30 at the DCSAV Spring cluster, and zoomed right into Advanced Rally the next day at the DCA Region II, taking a Q with a score of 92 – what a dog!

But mostly he's my buddy. We play and he invents new games, and he shops with me and makes life fun. That's what Alex told him was the job description for being my best friend. **Sawyer is owned by DVDC member Chris Baldwin.**
